5. Sealed bids must be submitted to the office of Naugad RM Hoparigad, Darchula by hand/courier on or before 12:00 hrs. on October 04, 2019 (Ashoj 17, 2076). Bids received after this deadline shall not be accepted.
6. The bids shall be opened in the presence of Bidders' representatives who choose to attend at 13:00 hrs on October 04, 2019 (Ashoj 17, 2076) at the office of Naugad RM office Hoparigad Darchula.

If bidder wishes to submit the Bid Security in the form of cash, the cash should be deposited in Naugad RM Darchula deposit Account No.120009065298501 (Mulsanchit Account) 120009065298504 (Security Deposit Account) at Janata Bank, Naugad and submit the receipt of the deposited amount of cash along with the bid.
