6. Electronic bids must be submitted to the office through PPMO website [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) on or before **12:00** noon on 31<sup>st</sup> October 2022 (2079/07/14 BS). Bids received after this deadline will be rejected.

The bids will be opened in the presence of Bidders' representatives who choose to attend at **2:00PM** on 31<sup>st</sup> October 2022 (2079/07/14 BS) at the office of Naugad RM Hoparigad Darchula. Bids must be valid for a period of 90 Day after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid, amounting to a minimum of **NRs Mentioned as below (2 to 3 % of estimated amount Exclusive VAT)]**, which shall be valid for 30 days beyond the validity period of the bid ie: 120 Day After Bid Opening.
